DIRECTIONS TO THE SHERATON STATION SQUARE HOTEL

From Pittsburgh International Airport

Take 60 South (Pittsburgh) to Interstate 279 North to Exit 5-C. Bear right and continue for approximately one mile. At the second light, turn right onto Carson Street (837). The hotel is approximately 1.5 miles on the left.

From East

Take Interstate 376 West to the Grant Street Exit (1C). Turn left at the first light onto Fort Pitt Boulevard. Stay in the left lane and go one block to Smithfield Street. Turn left at the light onto the Smithfield Street Bridge, and the Station Square entrance is at the end of the bridge.

From North

Take Interstate 79 South to I-279 South to Fort Pitt Bridge. Stay in the far right lane and exit 5-C (just before the tunnel). This will put you on Carson Street. (Route 837). Turn right at the first light and follow the access road to the hotel.

From South

Take Route 79 North to I-279 North (Pittsburgh). Take Exit 5-C (West End) and bear to the right. Continue for approximately one mile and at the second light, turn right onto Carson Street (837). The hotel is approximately 1.5 miles on the left.

TRANSPORTATION OPTIONS

SUPER SHUTTLE

NO RESERVATION IS REQUIRED FOR SERVICE FROM THE AIRPORT.

Departures leave the Airport every half hour Sunday - Friday: 7am - 11:30 pm and Saturday: 7am - 9pm. Tickets can be purchased at the desk. The cost is \$19.00 one way or \$38.00 round trip.

The service desk is centrally located on the landside, ground transportation level of Pittsburgh International Airport near the rental car counters and baggage claim. (Both domestic and international arrivals utilized the same baggage claim area.) It is identified by a large, lighted sign which reads, "Express Shuttle."

After you claim your luggage, please proceed to the Super Shuttle customer service counter located on the baggage claim level behind the escalators by Door 4.

RESERVATIONS ARE REQUIRED FOR THE SUPER SHUTTLE FROM THE SHERATON STATION SQUARE HOTEL TO THE AIRPORT.

LOCAL PARKING FACILITIES

SHERATON STATION SQUARE PARKING FACILITY
