DOE'S ALLOCATION OF FUNDS UNDER THE IJJA SECTION 40101(D) – FORMULA GRANTS TO STATES AND INDIAN TRIBES FOR PREVENTING OUTAGES AND ENHANCING THE RESILIENCE OF THE ELECTRIC GRID

The U.S. Department of Energy (DOE) has developed an approach for determining the allocation of funds under Sec. 40101(d) of the Infrastructure and Jobs Act¹ (42 U.S.C. 18711(d)) to States and Indian Tribes. This document presents the funding allocations by State and Tribal entity in Table 1.

Table 1 below displays the total funding distribution breakdown by factor for all eligible entities.
